The school engages weekly with all staff through regular staff meetings, bi monthly with the school Director team, monthly with the leadership team and monthly with the Board of Directors. Through this regular collaboration, all staff are represented, along with parents/guardians and members of the community.

The above stakeholder groups regularly analyze assets and gaps in the program overall looking at both historical data addressing all students and student subgroups in regards to academic achievement, mastery of knowledge and skills, high quality student work, and character and culture. Surveys are distributed annually school-wide to all students, teachers, staff, and families as well in order to gain feedback about our program and where the strengths and growth areas are. All plans around spending are developed over time with this input. The LCAP was brought to public board meetings and it addressed both regular and one time funding as well as spoke to collaboratively determined school goals that would influence our ESSER III funding plans. In addition, this plan will be approved at a public board meeting which allows for further comment and input from anyone in the public.

Stakeholder input generated through the regular collaboration as described above influenced this plan through identifying the need for additional teacher staffing, paraprofessional support, additional nursing time, and additional counseling time. These decisions arose from reviewing student assessment data, staffing plans, LCAP goals, and consideration of evidence-based options to individualize and systematize student support for those students who needed it most.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
